MINUTES

Minutes for November 17, 2010 meeting was distributed and read. A motion to accept the minutes was made by Director Duckett and seconded by Director Broussard. Motion carried.

TAX ASSESSOR REPORT

The Tax Assessor's report was distributed and read.

The Tax Assessor presented a letter from Mr. Freeman at 10550 Old Bammell N. Houston Rd. who is requesting that his taxes of \$394.36 be credited back to the June 18th 2006. The motion was made by Director Broussard and seconded by Director Duckett. Motion carried.

ENGINEER REPORT

The Engineer submitted pay request number 10 in the amounts of \$97,433.00 from Long and Son, Inc. for their work at the Deer Ridge Water Plant's Proposed Well and Emergency Generator Project. The engineer informed the board that the project is 95% complete. A motion was made by Director Lee and seconded by Director Duckett. Motion carried.

Cummins Southern Plains submitted two maintenance agreements for the generators at the Standpipe & Goldleaf Water Plants. The board reviewed and signed the agreements. The motion was made by Director Duckett and seconded by Director Broussard. Motion carried.

The Engineer submitted the received bids to bring Smiling Wood Lane to Harris County's acceptance. The board discussed each bid and granted a contract to Katy Construction for their bid of \$43,840.00. Director Duckett made the motion to accept the bid and the motion was seconded by Director Lee. Motion carried.

OPERATOR REPORT
