MINUTES

Minutes for February 15, 2012 meeting were distributed and read. A motion to accept the minutes was made by Director Duckett and seconded by Director McCharen. Motion carried.

TAX ASSESSOR REPORT

The Tax Assessor's report was distributed and read. Mr. G.C. Singh approached the board and asked to have the penalty and interest charges from 2005 - 2009, cleared on his account. After a brief discussion the board asked the Tax Assessor to look at Mr. Singh's charges and report back to the board. Director Sutton made the motion and Director Duckett seconded it.
